

Your Privacy is very important to us. The Kiwanis Club of Lombard has a few fundamental principles that we follow:

- We don't ask you for personal information unless we truly need it.
- We don't share your personal information with anyone except to comply with the law, develop our products, or protect your rights.
- We don't store personal information on our servers unless required for the ongoing operation of our site.

Kiwanis Club of Lombard operates several websites including www.kiwaniscluboflombard.org, www.facebook.com/kiwanisclubnoflombard, and www.twitter.com/kiwaniscluboflombard. It is Kiwanis Club of Lombard's policy to respect your privacy regarding any information we may collect while operating our websites.

Website Visitors

Like most website operators, Kiwanis Club of Lombard collects non-personally identifying information of the sort that web browsers and servers typically make available, such as the browser type, language preference, referring site, and the date and time of each visitor request. Kiwanis Club of Lombard's purpose in collecting non-personally identifying information is to better understand how Kiwanis Club of Lombard's visitors use its website. From time to time, Kiwanis Club of Lombard may release non-personally identifying information in the aggregate, e.g., by publishing a report on trends in the usage of its website.

Kiwanis Club of Lombard also collects potentially personally-identifying information like Internet Protocol (IP) addresses for logged in users and for users leaving comments on our blogs. Kiwanis Club of Lombard only discloses logged in user and commenter IP addresses under the same circumstances that it uses and discloses personally-identifying information as described below, except that blog commenter IP addresses are visible and disclosed to the administrators of the blog where the comment was left.

Gathering of Personally-Identifying Information

Certain visitors to Kiwanis Club of Lombard's websites choose to interact with Kiwanis Club of Lombard in ways that require Kiwanis Club of Lombard to gather personally-identifying information. The amount and type of information that Kiwanis Club of Lombard gathers depend on the nature of the interaction. For example, we ask visitors who comment on our blog to

provide a username and email address. Those who wish to receive Kiwanis Club of Lombard updates via email, we collect their emails. In each case, Kiwanis Club of Lombard collects such information only insofar as is necessary or appropriate to fulfill the purpose of the visitor's interaction with Kiwanis Club of Lombard.

Kiwanis Club of Lombard does not disclose personally-identifying information other than as described below. And visitors can always refuse to supply personally-identifying information, with the caveat that it may prevent them from engaging in certain website-related activities.

Aggregated Statistics

Kiwanis Club of Lombard may collect statistics about the behavior of visitors to its websites. For instance, Kiwanis Club of Lombard may monitor the most popular pages on the site or use spam screened by the Akismet service to help identify spam. Kiwanis Club of Lombard may display this information publicly or provide it to others. However, Kiwanis Club of Lombard does not disclose personally-identifying information other than as described below.

Protection of Certain Personally-Identifying Information

Kiwanis Club of Lombard discloses potentially personally-identifying and personally-identifying information only to those of its employees, contractors and affiliated organizations that need to know that information in order to process it on Kiwanis Club of Lombard's behalf such as those collected through 3rd party software (i.e. Mailchimp through blog subscription, PayPal donation, Google Analytics, Facebook page plugin) and that have agreed not to disclose it to others.

Kiwanis Club of Lombard will not rent or sell potentially personally-identifying and personally-identifying information to anyone other than its employees, contractors and affiliated organizations, as described above. Kiwanis Club of Lombard discloses potentially personally-identifying and personally-identifying information only in response to a subpoena, court order or other governmental requests, or when Kiwanis Club of Lombard believes in good faith that disclosure is reasonably necessary to protect the property rights of Kiwanis Club of Lombard, third parties or the public at large.

If you are a registered user of a Kiwanis Club of Lombard website and have supplied your email address, Kiwanis Club of Lombard may occasionally send you an email to tell you about new features, solicit your feedback, or just keep you up to date with what's going on with Kiwanis

Club of Lombard and our supporters. We primarily use our various blogs and website subpages to communicate this type of information, so we expect to keep this type of email to a minimum. If you send us a request (for example via a support email or via one of our feedback mechanisms), we reserve the right to publish it in order to help us clarify or respond to your request or to help us support other users. Kiwanis Club of Lombard takes all measures reasonably necessary to protect against the unauthorized access, use, alteration or destruction of potentially personally-identifying and personally-identifying information.

Cookies

A cookie is a string of information that a website stores on a visitor's computer, and that the visitor's browser provides to the website each time the visitor returns. Kiwanis Club of Lombard uses cookies to help Kiwanis Club of Lombard identify and track visitors, their usage of Kiwanis Club of Lombard website, and their website access preferences. Kiwanis Club of Lombard visitors who do not wish to have cookies placed on their computers should set their browsers to refuse cookies before using Kiwanis Club of Lombard's websites, with the drawback that certain features of Kiwanis Club of Lombard's websites may not function properly without the aid of cookies.

Business Transfers

If Kiwanis Club of Lombard or substantially all of its assets were occupied, or in the unlikely event that Kiwanis Club of Lombard is dissolved, user information would be deleted.

Comments and other content submitted to Akismet anti-spam service are not saved on our servers unless they were marked as false positives, in which case we store them long enough to use them to improve the service to avoid future false positives.

Privacy Policy Changes

Although most changes are likely to be minor, Kiwanis Club of Lombard may change its Privacy Policy from time to time, and in Kiwanis Club of Lombard's sole discretion. Kiwanis Club of Lombard encourages visitors to frequently check this page for any changes to its Privacy Policy.
