

## **2021 “Peanut Day” Ordering Process**

Welcome to “year three” of the new “Peanut Day” ordering process.

After COVID-19 severely impacted Club’s 2020 Peanut Day fundraising efforts most are anxiously looking forward to better results in 2021. Although I know of one Club that had sales in excess of \$30K many Clubs were much less successful in their related fundraising efforts. The good news is that all of last year’s vendors are returning PLUS an additional vendor (Boxed) that was identified and utilized last year by the Kiwanis Club of Dixon, IL. More information about this company is noted below.

I continue to encourage Divisions to consolidate their orders so that the individual clubs can save on shipping costs.

The following are the details for our 2021 Peanut Day Fundraising efforts:

### **Boxed**

Boxed was founded in 2013 by an experienced group of tech pioneers with a simple idea: make shopping for bulk easy, convenient, and fun, so you can focus on the things that really matter. The company buys products directly from the manufacturer and then ships the product(s) to the end user. The customer can order a single unit of any product, a truckload or a train car. Whatever quantity they require. More information about Boxed can be found on their website.

Product” 48 1oz. Planters salted peanuts

Cost: \$7.89/box

Unit Cost: \$0.16

Minimum order: \$19.99

Shipping Cost: Free on orders greater than \$49.00

(Note: when ordering you must provide your Club Tax ID number to avoid paying sales tax.)



**Terri Lynn - All orders must be placed 4 weeks before they are required to ensure timely delivery**

Product: 100ct 3/4oz Roasted Peanuts 4 boxes to a carton and can only be ordered by whole carton

Cost: \$16.50/box or \$66.00 per carton

Unit cost: \$.165/package

(Note: This pricing may change as TerriLynn is currently reviewing all of their product pricing. It is not expected that this price will decrease as peanut prices processing costs have increased over the past year.)

Payment: All payments can be made via check or credit card either at the time of the order being placed or upon pickup. If the order is being shipped Terry Lynn will determine the shipping cost and provide that cost to the buyer within 24 hours of the time orders are placed.

For any orders that qualify for tax-exempt status, the order will need to include documentation (Tax ID number) for each Club/Division that is placing the order.

**King Nut – All orders must be placed four (4) weeks before they are required to ensure timely delivery**

Product: (4) 100 count boxes of .5oz King's brand honey roasted peanuts master packed into one case for \$68.45 each.

Product: (4) 100 count boxes of .42oz Summer Harvest mini pretzels master packed into 1 case for \$56.00 each.

**Pricing for the 450 count bulk cases only:**

.5oz honey peanuts (18 polybags of 25 each) are \$87.01 for a quantity of 1-20 cases. For exceeding 20 cases the price is \$69.04 per case.

.42oz mini pretzels (18 polybags of 25 each) are \$68.45 for a quantity of 1-20 cases. For orders exceeding 20 cases the price is (being negotiated) per case.

**Each of the 450 count cases will contain "Kiwani's Thanks You" stickers that can be applied to the individual packages**

Prices are FOB Solon, OH.
